THEREAS, this addrest Body is in receipt of Ordinance No. 04 s. 1993 the Partngay Chuncil of Brgy. Camp Downes, this city, entitled "An Ordinance requiring the residents of Barangay Camp Downes, Ormoc City, to provide their use receptables for garbage and refuse collection pursuant to Article 20 of Ordinance No. 39, otherwise known as the pursuant Revised 1970 Sanitery Code of Ormoc City";

WHEREAS, this sanggunian, in relation to the aforecited ordinance issue (and all other ordinances of the mga sanggunian barangay in Ormoc (ty) is, by law, granted with the power to review on whether the said ordinance is consistent with law and city X X X ordinances. (Sec. 57 LGC 1991);

WHEREAS, it is the observation of this august Body, through the representation of the Honorable Chairman, Committee on Laws & Ordinances, that the aforesaid ordinance is defective specifically Section 7 thereof on provision about imprisonment, for, under the Local Government Code, a barangay council cannot exact a penalty of imprisonment;

NOW, THEREFORE, on motion of Kagawad Mariano Y. Corro, Chairman, Committee on Laws & Ordinances, duly seconded by Kagawad Benjamin B. Lladoc; be it

RESOLVED, AS IT IS HEREBY RESOLVED, to return to the Barangay Council of Brgy. Camp Downes, this city, its Ordinance No. 04 s. 1993 with an advice that Section 7 thereof be corrected accordingly by deleting the penalty of imprisonment;
