RESOLUTION NO. 10

A RESOLUTION REQUESTING THE CITY PLANNING OFFICE IN COORDINATION WITH THE CITY HEALTH OFFICE, GENERAL SERVICES OFFICE AND THE POLLUTION CONTROL OFFICE TO STUDY AND/OR MAKE ALTERNATIVE PLANS FOR THE IMPROVEMENT/SANITATION/ PROPER MAINTENANCE OF THE CITY'S GARBAGE DISPOSAL AREAS AND RECOMMENDATIONS TO THE OFFICE OF THE CITY MAYOR AND THE SANGGUNIANG PANLUNGSOD WITHIN SIXTY (60) DAYS FROM RECEIPT HEREOF.

WHEREAS, Article 99, paragraph 5, sub-paragraph XIII of the Rules and Regulation Implementing the Local Government Code in consonance with Article Three Sec. 457, par. 5, sub-paragraph XIII states that:

Among the responsibilities of the Sangguniang Panlungsod is to "Provide for an efficient and effective system of solid waste and garbage collection and disposal and prohibit littering and the placing or throwing of garbage, refuse and other filth and waste";

WHEREAS, the city's garbage dump site located in Barangay Macabug is in a very unsanitary condition, and is environmentally and ecologically hazardous;

WHEREAS, for the better protection and welfare of the community nearby and to prevent the eutrophication of Panilahan River and the degradation of Ormoc Bay, a study and long term plan and/or alternatives should be made regarding the city's dump site area;

NOW, THEREFORE, on motion of Kagawad Jose C. Alfaro, Jr, severally seconded by mga Kagawad Mariano Y. Corro, Claudio P. Larrazabal and Benjamin B. Lladoc; be it



RESOLVED, AS IT IS HEREBY RESOLVED, to request the City Planning Office in coordination with the City Health Office, the General Services Office and the Pollution Control Office to study and/or make alternative plans for the improvement/sanitation/proper maintenance of the city's garbage disposal areas and to submit a copy of the plans and recommendation to the Office of the City Mayor and the Sangguniang Panlungsod within Sixty (60) days from receipt hereof;

ENACTED, January 13, 1994.

RESOLVED, FURTHER, to furnish copies of this resolution each to His Honor, the City Mayor; to the OIC, DENR-CENRO, Ormoc, the City Planning and Development Coordinator; the OIC, Office of the General Services; the Pollution Control Officer and others concerned, -all in Ormoc City;
