## RESOLUTION NO. 14

A RESOLUTION CONFIRMING THE WITHDRAWAL OF THE AMOUNT OF FIVE MILLION PESOS (\$5,000,000.00) FROM THE GENERAL FUND DEPOSITED WITH THE LAND BANK, ORMOC CITY.

WHEREAS, this august Body is in receipt of a letter from Mr. Godofredo A. Sevilla, former City Treasurer, this city dated 14 January 1994 addressed to the Hundrable Sangguniang Panlungsod thru the Honorable City Mayor, the full text of which is herein cited as follows:

The Honorable Sangguniang Panlungsod Members Ormoc City Thru the Honorable City Mayor Ormoc City

Sentlemen:

May I request that august Body to pass a resolution confirming the withdrawal of the amount of FIVE MILLION PESOS (P5,000,000.00) from the General Fund and deposited with the Land Bank, Ormoc Branch last November 11, 1992. The amount transferred was intended for the payment of the salaries and wages of laborers due to the fact that the current account of the city was almost exhausted. Since the need for the fund was urgent, the transfer thru oversight was effected without the necessary resolution, hence this request.

Favorable action of the above request is highly appreciated.
