RESOLUTION NO. 19

A RESOLUTION AUTHORIZING THE HONORABLE CITY MAYOR EUFROCINO M. CODILLA, SR., TO SIGN THE CONTRACTUAL APPOINTMENT OF DR. JOSEPH C. CORTES AS VETERINARIAN V, SUBJECT TO THE CONDITION THAT PERA AND RATA SHOULD BE EXCLUDED EXCEPTING ADDITIONAL COMPENSATION AND YEAR-END BENEFITS.

WHEREAS, this august Body is in receipt of a letter from the Honorable City Mayor, dated 3 January 1994, addressed the Honorable Vice-Mayor and Presiding Officer, requesting for the passage of a resolution granting him with authority to sign the contractual employment of Dr. Joseph C. Cortes as Veterinarian V, this city;

WHEREAS, the Honorable City Mayor in said letter, cited among others, the importance and the urgency of the services of Dr. Joseph C. Cortes as Veterinarian V of the City Government of Ormoc;
