A RESOLUTION AUTHORIZING THE HONORABLE DITY MAYOR EUFROCINO M. CODIZLA, SR., TO SIGN THE CONTRACTUAL APPOINTMENT OF DR. JOSEPH C. CONTES AS VETERINARIAN V, SUBJECT TO THE CONDITION THAT PERG AND RATA SHOULD BE EXCLUDED EXCEPTING ADDITIONAL COMPENSATION AND YEAR-END BENEFITS.

WHEREAS, this august Body is in receipt of a letter from the Honorable City Mayor, dated 3 January 1994, addressed the Honorable Vice-Mayor and Presiding Officer, requesting for the passage of a resolution granting him with authority to sign the contractual employment of Dr. Joseph C.
