A RESOLUTION AUTHORIZING THE HONORABLE CITY MAYOR TO
DESIGNATE CIVIL SERVICE PERSONNEL TO ASSIST THE ORMOC CITY
POLICE - TRAFFIC DIVISION, IN MAINTAINING AND SUPERVISING
THE TRAFFIC OF THE CITY.

WHEREAS, the Sangguniang Panlungsod ng Ormoc is in receipt of a
letter dated 24 January 1994 from the Chief of Police, PNP, Ormoc City,
the text of said letter is hereunder cited as follows:

In view of the depleted strength of this command,
particularly in the Traffic Enforcement Management, I see it
after thorough observation that our present Traffic Aide
Personnel is very effective and efficient.

It is in this manifestation that I strongly request this August Body thru the Chairman Committee on Police, Fire and Public Safety that a resolution be passed and favorably acted giving this station full control and supervision over this personnel in the Traffic Enforcement.

Anticipating that this request would merit your most preferential attention.

WHEREAS, this august Body, through the representation of the Honorable Chairman, Committee on Police, Fire & Public Safety, has considered the aforementioned request meritorious, hence, be accorded with due course of action, with the following comments:

- a) The said appointed personnel shall be referred to as traffic aides and shall be under the direct supervision of the head of the traffic division of the Ormoc City Police Station and follow the chain of command of the Police Department;
- b) In accordance with the civil service rules and regulations for government personnel, these traffic aides may be terminated by the designating authority or returned to their original assignments;
- c) Salaries of traffic aides shall be taken from the budget appropriated for Civil Security Services, the Mayor may however give them proper incentives and/or financial assistance within his discretionary authority;
- d) This resolution shall take effect upon its approval.

NOW, THEREFORE, on motion of Kagawad Jose C. Alfaro, Jr., Chairman, Committee on Police, Fire and Public Safety, jointly seconded by mga Kagawad Benjamin B. Lladoc and Celso P. Adolfo; be it

RESOLVED, to pass a resolution AUTHORIZING THE HONORABLE CITY MAYOR TO DESIGNATE CIVIL SERVICE PERSONNEL TO ASSIST THE ORMOC CITY POLICE - TRAFFIC DIVISION, IN MAINTAINING AND SUPERVISING THE TRAFFIC OF THE CITY;

ENACTED, January 27, 1994.

RESOLVED, FURTHER, to furnish copies of this resolution each to His Honor, the City Mayor; the City Administrator, the City Legal Officer, the City Prosecutors Office, the METRODISCOM Headquarters- Camp Downes, and the Chief of Police, PNP, -all in Ormoc City;
