## RESOLUTION NO. 25

WHEREAS, this august Body is in receipt of a letter from the President of Ormon City Motor Cab Operators and Drivers Association (OCMDA) dated 31 January 1994, requesting for approval to have an increase of fifty (.50) centavos in fare rates in addition to the former rates;

WHEREAS, the Sixth Sangguniang Panlungsod, through the representation of the Honorable Chairman, Committee on Transportation and Communications has considered said request as invalid for it lacks the necessary Board Resolution considering that OCMODA, is a non-stock, non-profit organization registered with the Securities and Exchange Commission (SEC);

NOW, THEREFORE, on motion of Kagawad Jose C. Alfaro, Jr., Chairman, Committee on Transportation and Communications duly seconded by Kagawad Claudio P. Larrazabal; be it

RESOLVED, AS IT IS HEREBY RESOLVED, to disapprove the request of Ormoc City Motor Cab Operators and Drivers Association (OCMODA) for fare rates increase;
