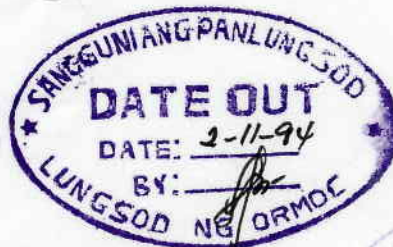

#### RESOLUTION NO. 28

A RESOLUTION AUTHORIZING THE HONORABLE CITY MAYOR TO  
NEGOTIATE WITH MRS. JUANA DAFFON FOR THE PURCHASE OF HER  
LOTS (NOS. 5272-C AND 5274-A) WITH AN AREA OF 24,422 SQ.  
M. AND 5,199 SQ. M. RESPECTIVELY, LOCATED AT BARANGAY  
TAMBULILID, ORMOC CITY, FOR RESETTLEMENT PURPOSES, AND TO  
SIGN THE CORRESPONDING DEED OF ABSOLUTE SALE, SUBJECT TO  
THE AVAILABILITY OF FUNDS.

WHEREAS, this august Body is in receipt of a letter from the  
Honorable City Mayor dated 7 February 1994, addressed to the Honorable  
Vice-Mayor and Presiding Officer, requesting for authority to negotiate  
with Mrs. Juana Daffon for the purchase of her lots (nos. 5272-C and  
5274-A) with an area of 24,422 sq. m. and 5,199 sq. m., respectively,  
located at Brgy. Tambulilid this city, for resettlement purposes;

WHEREAS, per Resolution No. 02-94 of the City Appraisal Committee  
dated 19 January 1994, said lots (nos. 5272-C and 5274-A) were duly  
appraised at P70.00 per square meter;

WHEREAS, the City Budget Officer through 2nd Indorsement dated 17,  
November 1993 has stated that the remaining balance of the account -  
Acquisition of Lot is only P871,309.80;

WHEREAS, the OIC - City Treasurer, OIC through 11th Indorsement  
dated 9 February 1994 has emphasized that the source of fund for the  
purchase of Mrs. Juana Daffon's lots for resettlement purposes be taken  
from the account Acquisition of Lot is available;

WHEREAS, official documents evidencing absolute transfer of  
ownership of said property is indispensable for records file in  
government office/s concerned;



NOW, THEREFORE, on motion of Kagawad Alfredo F. Capahi, Chairman, Committee on Finance, duly seconded by Kagawad Celso P. Adolfo; be it


RESOLVED, AS IT IS HEREBY RESOLVED, to authorize the Honorable City Mayor to negotiate with Mrs. Juana Daffon for the purchase of her lots (nos. 5272-C and 5274-A) with an area of 24,422 sq. m. and 5,199 sq. m., respectively, located at Brgy. Tambulilid, Ormoc City, for resettlement purposes, and to sign the corresponding Deed of Absolute Sale, subject to the availability of funds;
