A RESOLUTION STRONGLY SUPPORTING RESOLUTION NO. 94-15 S.
1994 OF THE SANGGUNIANG PANLALAWIGAN OF THE PROVINCE OF
ILOILO, ENTITLED "RESOLUTION FOR SUPPORT TO THE COMPLAINT
AILED BY THE MUNICIPAL MAYORS LEAGUE OF THE PROVINCE OF
ILOILO AGAINST THE DEPARTMENT OF PUBLIC WORKS AND
HIGHWAYS, REGION VI, FOR NON-OBSERVANCE OF MANDATORY
CONSULTATION AND COORDINATION WITH THE LOCAL GOVERNMENT
UNIT CONCERNED AS PROVIDED FOR IN ART. 55, RULE 11, OF THE
RULES AND REGULATIONS IMPLEMENTING THE LOCAL GOVERNMENT
CODE OF 1991, IN RELATION TO SECTION 25, CHAPTER 3, UNDER
THE TITLE "INTER-GOVERNMENTAL RELATIONS" OF THE LOCAL
GOVERNMENT CODE OF 1991, AND TO URGE AND ENJOIN THE
REGIONAL DIRECTOR, DPWH, REGION VI, TO OBSERVE INTER-
GOVERNMENTAL RELATIONS, AS MANDATED BY THE LOCAL
GOVERNMENT CODE."

WHEREAS, the Sangguniang Panlungsod ng Ormoc is in receipt of
Resolution No. 94-15 s. 1994 from the Sangguniang Panlalawigan of
Iloilo;

WHEREAS, this august Body has conformed to the propriety and
embodiment of said resolution, to be more precious, on mandatory
consultation and coordination requirements as provided by law on the
part of the Regional Director, DPWH, Region VI, to observe and comply on
the following acts and things:

- 1) to conduct periodic consultations with appropriate local
government units before any project or program is
implemented in their respective jurisdictions;
- 2) to coordinate with local government units concerned in the
discharge of the project implementation functions; and

- 3) to ensure the participation of local government units both in the planning and implementation of national projects.

NOW, THEREFORE, on motion of Kagawad Claudio P. Larrazabal, Chairman, Committee on Infrastructures, severally seconded by mga Kagawad Jose C. Alfaro, Jr., Alfredo F. Capahi and Fernando P. Parrilla; be it

RESOLVED, AS IT IS HEREBY RESOLVED, to strongly support Resolution No. 94-15 s. 1994 of the Sangguniang Panlalawigan of the Province of Iloilo, entitled "Resolution of support to the complaints aired by the Municipal Mayors' League of the Province of Iloilo against the Department of Public Works and Highways, Region VI, for Non-Observance of Mandatory Consultation and Coordination with the Local Government Unit concerned as provided in Art. 55, Rule 11, of the Rules and Regulations implementing the Local Government Code of 1991, in relation to Section 25, Chapter 3, under the title "Inter-Government Relations" of the Local Government Code of 1991, and to urge and enjoin the Regional Director, DPWH, Region VI, to observe inter-governmental relations, as mandated by the Local Government Code";
