RESOLUTION NO. 32

A RESOLUTION AUTHORIZING THE HONORABLE CITY MAYOR TO
NEGOTIATE WITH PETRONILA L. TUALLA AND ANTONIO MACABUHAY
FOR THE PURCHASE OF THEIR LOTS, (LOT NO. 3481-B OF
PETRONILA TUALLA AND LOT NO. 3477-G-4 OF ANTONIO
MACABUHAY), WITH AN AREA OF 144 SQ. METERS AND 1,430 SQ.
METERS, RESPECTIVELY, BOTH SITUATED AT BRGY. DANHUG, ORMOC
CITY, FOR ROAD-RIGHT-OF-WAY PURPOSES, AND TO SIGN THE
CORRESPONDING DEEDS OF ABSOLUTE SALE.

WHEREAS, this sanggunian is in receipt of a letter-indorsement
dated 31 January 1994 from the Office of the City Mayor requesting
legislative action of the following road right of way claims:

- a) Claimant Petronila L. Tualla of Lot No. 3481-B situated at
Brgy. San Antonio (now Danhug), Ormoc City, containing an
area of 144 square meters;
- b) Claimant Antonio Macabuhay of Lot No. 3477-G-4, Psd. 08-
004149 situated at Brgy. Danhug, Ormoc City, with an area
of 14,430 square meters.

WHEREAS, through Certifications issued by the City Engineer dated 22
November 1993 and by the Tax Mapper IV, City Assessor's Office, dated 25
November 1993, said Lots Nos. 3481-B and 3477-G-4 are both being
traversed by existing Barangay roads;

WHEREAS, through Resolution No. 10-93 dated 18 November 1993 of
the City Appraisal Committee, both Lots Nos. 3481-B and 3477-G-4 are
appraised at P70.00 per square meter;

WHEREAS, official documents evidencing absolute transfer of
ownership of said lots is indispensable for records file in government
office/s concerned;

NOW, THEREFORE, on motion of Kagawad Mariano Y. Corro, Chairman, Committee on Public Properties, duly seconded by Kagawad Sotero M. Pepito; be it


RESOLVED, AS IT IS HEREBY RESOLVED, to authorize the Honorable City Mayor to negotiate with Petronila L. Tualla and Antonio Macabuhay for the purchase of their lots, (Lot No. 3481-B of Petronila Tualla and Lot No. 3477-B-4 of Antonio Macabuhay), with an area of 144 square meters and 1,430 square meters, respectively, both situated at Brgy. Danhug, Ormoc City, for road-right-of-way purposes, and to sign the corresponding Deeds of Absolute Sale;
