RESOLUTION NO. 33

A RESOLUTION DECLARING THE MONTHS OF FEBRUARY TO JUNE OF  
EVERY YEAR INCLUSIVE AN OPEN SEASON ALLOWING THE USE OF  
FINE MESH NET FOR FISHING AND THE MONTHS OF JULY TO  
JANUARY OF EVERY YEAR INCLUSIVE AS CLOSED SEASON.

WHEREAS, in consonance with the Fishery Ordinance No. 38 s. 1993,  
Sec. 16, Paragraph D to declare the months of February to June of every  
year inclusive an open season allowing the use of fine mesh net for  
fishing and the months of July to January of every year as closed  
season;

WHEREAS, it is provided for in Sec. 16, Paragraph D of Fishery  
Ordinance No. 38 s. 1993 that:

"d) No person shall engage in fishing using nets with mesh  
smaller than three (3) centimeters; Provided, that this  
prohibition shall not apply to species which by their very  
nature are smaller but already mature and during specified  
season as may be determined by the Sanggunian in a resolution  
for catching said species."

WHEREAS, the Sangguniang Panlungsod ng Ormoc, upon recommendation  
of the fishermen concerned and the Department of Agriculture and  
Fisheries, has identified the months which should be specified as closed  
season;

NOW, THEREFORE, on motion of Kagawad Jose C. Alfaro, Jr., Chairman,  
Committee on Natural Resources & Environmental Control, jointly seconded  
by mga Kagawad Claudio P. Larrazabal and Alfredo F. Capahi; be it

RESOLVED, AS IT IS HEREBY RESOLVED, to declare the months of  
February to June of every year inclusive an open season allowing the use  
of fine mesh net for fishing and the months of July to January of every  
year inclusive as closed season;


