RESOLUTION NO. 41

A RESOLUTION AUTHORIZING THE HONORABLE CITY MAYOR TO
GRANT ADDITIONAL EXTENSION OF THE DEADLINE FOR
REGISTRATION/RENEWAL OF PERMITS/LICENSING OF
BUSINESSES FROM FEBRUARY 28 TO MARCH 21, 1994.

WHEREAS, the Ormoc Filipino Retailers' Association through a letter dated 21 February 1994 addressed His Honor, the City Mayor, and the latter having endorsed the same to the Honorable Sangguniang Panlungsod for appropriate action, has requested for another extension of the deadline for the renewal of city licenses/mayor's permits from February 28 to March 21, 1994, alleging therein that the majority of the retailers-members thereof have not yet fully complied with the requisites for the issuance of city licenses/mayor's permit, besides, "during the month of January, we have to pay out city taxes, BIR taxes, real property taxes, water bills, market fees and other taxes which have substantially drained our financial resources";

WHEREAS, in view of the aforesaid request, and notwithstanding earlier passage of Resolution No. 11 s. 1994 which had authorized the City Mayor to extend the deadline of registration/renewal of permits/licensing of businesses from January 21 to February 28, 1994, this august Body still has considered logical on allowing for additional extension of said deadline in order to provide not only the members of the aforementioned retailers association but also all taxpayers with ample time to meet the various tax requirements and pay their tax obligations to the government;

NOW, THEREFORE, on motion of Kagawad Alfredo F. Capahi, Chairman, Committee on Finance, duly seconded by Benjamin B. Lladoc; be it

RESOLVED, AS IT IS HEREBY RESOLVED, to authorize the Honorable City Mayor to grant additional extension of the Deadline for Registration/Renewal of Permits/Licensing of Businesses from February 28 to March 21, 1994;

ENACTED, February 24, 1994.

RESOLVED, FURTHER, to furnish copies of this resolution each to His Honor, the City Mayor; the City Administrator, the City Treasurer, the City Auditor and the President- Ormoc Filipino Retailers' Association, - all in Ormoc City;

CARRIED UNANIMOUSLY.


