A RESOLUTION AUTHORIZING THE HONDRABLE CITY MAYOR TO GRANT ADDITIONAL EXTENSION OF THE DEADLINE FOR REGISTRATION/RENEWAL OF PERMITS/LICENSING BUSINESTES FROM FEBRUARY 28 TO MARCH 21, 1994.

HEREAS, the Crook Filipino Retailers' Association through a letter 11 February 1964 addressed His Honor, the City Mayor, and the having endorsed the same to the Honorable Sangguniang Panlungsod for appropriate action, was requested for another extension of the deadline for the renexal of city licenses/mayor's permits from February to March 21, 1994, alleging therein that the majority of the retailers—members thereof have not yet fully complied with the requisites for the issuance of city licenses/mayor's permit, besides, during the month of January, we have to pay out city taxes, BIR taxes, al property taxes, water bills, market fees and other taxes which have substantially drained our financial resources";

WHEREAS, in view of the aforesaid request, and notwithstanding earlier passage of Resolution No. 11 s. 1994 which had authorized the City Mayor to extend the deadline of registration/renewal of permits/licensing of businesses from January 21 to February 28, 1994, this august Body still has considered logical on allowing for additional extension of said deadline in order to provide not only the members of the aforenamed retailers association but also all taxpayers with ample time to meet the various tax requirements and pay their tax obligations to the government;

NOW, THEREFORE, on motion of Kagawad Alfredo F. Capahi, Chairman, Committee on Finance, duly seconded by Benjamin B. Lladoc; be it
