RESOLUTION NO.

A RESOLUTION DISAPPROVING ONDINANCE NO. 01 S. 1994 OF THE COUNCIL OF BARANGAY CAN-UNTOS, THIS CITY, "IN ORDINANCE IMPOSING TOLL FEES ON ALL TRUCK OF SAND, GRAVEL AND OTHER MINING AGGREGATES HAULERS TAROUGA PARANGAY ROADS OF BARANGAY CAN-UNTOG, PASSING DANOC CIT

this august Body is in receipt of Resolution No. 02 s. on the Barangay Council of Cam-untog, this city, embodying Ordinance 01 s. 1994 entitled "An Ordinance imposing Toll Fees on all truck of Sand, Gravel and other Mining Aggregates passing through barangay roads of Barangay Can-untog, Ormoc City";

WHEREAS, the City Legal Officer through 3rd Indorsement dated 2 March 1994 has the following comments:

Ordinance No. 1 s. 1994 of Barangay Can-untog is unconstitutional for being a class legislation. The said ordinance is discriminatory against truck haulers of sand, gravel and other mining aggregates only. How about truck haulers of other goods, which may frequently pass the roads of Brgy. Can-untog? Art. III, Sec. 2 of the Constitution provides:

"No person shall be deprived of life, liberty, or property without due process of law, nor shall any person be denied the equal protection of the laws."

2) Said Ordinance in reality levies a fee on the sand gravel and other mining aggregates being hauled by the truck which is beyond its taxing powers as provided under Sec. 133 of the Local Government Code quoted hereunder:

"Sec. 133. Common Limitation in the Taxing Powers of Local Government Units. - Unless otherwise provided herein, the exercise of the taxing powers of provincies, cities, municipalities, and barangays shall not extend to the levy of the following:

X X X

e) Taxes, fees and charges and other impositions woun goods carried into in or out of, or passing through, the territorial jurisdictions of local government units in the guise of charges for wharfage, tolls for bridges or otherwise, or other taxes, fees or charges in any form whatsoever upon such goods or merchandise."

WHEREAS, the Sixth Sangguniang Panlungsod ng Ormoc through a communication dated 18 February 1984 addressed to the Sangguniang Barangay of Brgy. Can-untra inquired as to whether a public hearing was conducted by the said Sangguniang Barangay prior to the approval of said ordinance considering that this ordinance imposes toll fees, but unfortunately, as of this date, no reply was received by this august Body from the said Barangay;

NOW. THE PEORE, on motion of Kagawad Mariano Y. Corro, Chairman, Committee on Lava and Ordinances, severally seconded by Kagawad Claudio P. Larrazabal, Alfred F. Capahi and Jose C. Alfaro, Jr; be it

RESOLVED, AS IT IS HEREBY RESOLVED, to disapprove Ordinance No. 1. 1994 of the Barangay Council of Can-untog, this city, entitled "An Ordinance imposing foll Fees on all truck haulers of Sand, Gravel and Other Mining Degregates passing through barangay roads of Brgy. Can-untog Ormoc City.", in the view of the reasons stated above.

RESOLVED, FURTHER, to furnish copies of this resolution each to His Honor, the City Mayor, the City Administrator, the Honorable ABC President, the DILG-ACGO Officer and the Honorable Punong Barangay of Brgy. Can-untog, -all in Ormoc City;
