RESOLUTION NO. 49

A RESOLUTION CREATING THE CITY PHYSICAL FITNESS AND SPORTS  
DEVELOPMENT COUNCIL OF ORMOC.

WHEREAS, there is a true need on providing our people, particularly  
the youth, with the opportunity to develop strong and healthy body and  
spirit through sports and athletic games;

WHEREAS, this display of talents for noble and patriotic purpose  
cannot be achieved by the schools working alone, for no matter how much  
effort and interest are poured into the process of preparing the  
athletes for a competition, there can be little or no success at all if  
other agencies in the government, the NGOs and POs are not positively  
involved and, our people are not motivated hence only to develop a  
negative or no-interest attitude which too often were the causes of  
failures and disappointments in many local, provincial, regional and  
national athletic meets in the past;

WHEREAS, very fortunately, His Excellency, President Fidel V. Ramos  
has issued Executive Order No. 63 s. 1993 Re: Creating the National,  
Regional, Provincial, City, Municipal and Barangay Physical Fitness and  
Sports Development Council, which, under this Executive Order, the City  
Government of Ormoc, among others, shall create its City Physical  
Fitness and Sports Development Council (PFSDC) with duties and functions  
so provided under Section 2 with Pars. 1 to 7 thereof;

WHEREAS, the Honorable MEMBERS of the SANGGUNIANG PANLUNGSOD, in  
SESSION, in compliance with said Executive Order No. 63 and mindful to  
the true needs on improving the quality of training and management on  
sports and physical fitness in the locality, on the recruitment and  
possible selection of gifted and talented athletes (for Ormoc City to  
serve as one base in nationwide selection of national athletes),  
etcetera, WHEREFORE, pronounce due course of action in this regard;

(d) - Executive Order 63 s. 1993);

CARRIED by MAJORITY VOTES, with ten (10) affirmative votes, and one (1) abstention registered by Kagawad Sixto T. Pongos.
