RESOLUTION NO. 50

A RESOLUTION REQUESTING THE HONORABLE SECRETARY, DEPARTMENT OF INTERIOR AND LOCAL GOVERNMENT, THROUGH HONORABLE YOLANDA DE LEON, ASSISTANT SECRETARY FOR PLANS AND PROGRAMS, DILG, FOR TWO (2) FIRE TRUCKS FOR THE ORMOC FIRE DEPARTMENT, TWO (2) PATROL VEHICLES FOR PNP ORMOC, AND TWO (2) DUMP TRUCKS FOR THE USE OF THE GENERAL SERVICES DEPARTMENT OF THE CITY OF ORMOC.

WHEREAS, there are only four (4) operational fire trucks of the Ormoc Fire Department servicing a large area of a fast growing city with 110 barangays, and the said fire department also assist in the fire fighting operations of the neighboring towns of Isabel, Merida, Kananga, Albura, Baybay, Palompon and Villaba in time of need;

WHEREAS, there are more than 136,000 inhabitants of the city with an area of 48,826 hectares who are supposedly to be given with protection against the commission of crimes against life or property by only 60 Police Officers with only two (2) service vehicles available for use;

WHEREAS, two serviceable units of Compactors and two dump trucks of the city aren't enough number of vehicles for use in collecting the garbage and other waste disposals of the city;

WHEREAS, according to a very reliable source, the Department of Interior and Local Government has these kinds of vehicles being programmed for distribution to all LGUs in need throughout the country;

WHEREAS, the City Government of Ormoc and this august Body realize the need for additional vehicles that can be utilized for effective and efficient implementations of programs for fire prevention and public safety, peace and order, and city beautification and cleanliness;

NOW, THEREFORE, on motion of Kagawad Jose C. Alfaro, Jr., Chairman, Committee on Police, Fire & Public Safety, jointly seconded by mga Kagawad Claudio P. Larrazabal and Alfredo F. Capahi; be it

RESOLVED, to pass a resolution REQUESTING THE HONORABLE SECRETARY, DEPARTMENT OF INTERIOR AND LOCAL GOVERNMENT, THROUGH HONORABLE YOLANDA DE LEON, ASSISTANT SECRETARY FOR PLANS AND PROGRAMS, DILG, FOR TWO (2) FIRE TRUCKS FOR THE ORMOC FIRE DEPARTMENT, TWO (2) PATROL VEHICLES FOR PNP ORMOC, AND TWO (2) DUMP TRUCKS FOR THE USE OF THE GENERAL SERVICES DEPARTMENT OF THE CITY OF ORMOC;


