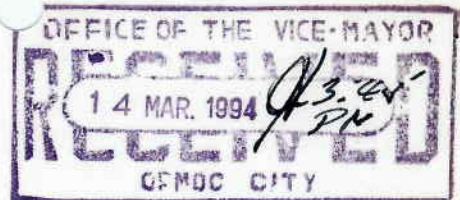

RESOLUTION NO. 52

A RESOLUTION COMMENDING THE EFFORTS OF THE ORMOC CITY  
PROSECUTORS' OFFICE HEADED BY CITY PROSECUTOR ALBERTO L.  
CONOPPIO FOR THE EFFICIENT PERFORMANCE OF HIS OFFICE IN THE  
SPEEDY DISPOSAL OF CASES AND FOR WORK WELL DONE AS  
EVIDENCED BY THE LETTER OF THE HONORABLE SECRETARY OF  
JUSTICE FRANKLIN M. DRILON.

WHEREAS, the Hon. CITY MAYOR of ORMOC is in receipt of a copy of a  
letter from the Honorable Secretary of Justice, Franklin M. Drilon,  
dated 31 January 1994, re: the report on the accomplishment of the  
provincial and city prosecution offices within their respective regions  
during the corporate planning for 1994 for the National Prosecution  
Service conducted by the Dept. of Justice on January 20 and 21, 1994;

WHEREAS, the Honorable Franklin M. Drilon in said letter is pleased  
to inform the Honorable City Mayor of Ormoc that of the total number of  
284 criminal complaints handled by the Office of the Ormoc City  
Prosecutor in 1993, 272 were resolved, indicating a 96% disposition rate;

WHEREAS, the performance of the Office of the Ormoc City Prosecutor  
headed by Prosecutor Alberto L. Conopio in said year indicates that the  
Prosecutors had been markedly conscientious in their work and had fully  
become cognizant of their role in the administration of justice;
