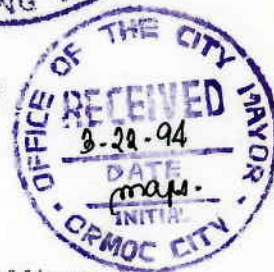

RESOLUTION NO. 55

A RESOLUTION APPROVING TAX ORDINANCE NO. 01 S. 1993 OF THE
BARANGAY COUNCIL OF DAYHAGAN, ORMOC CITY, ENTITLED "AN
ORDINANCE IMPOSING A TAX ON RETAIL (SARI-SARI) STORES
OPERATING WITHIN THIS BARANGAY, AND CHARGING A FEE ON THE
USE OF ANY PORTION OF THE BARANGAY MULTI-PURPOSE PAVEMENTS
FOR DRYING GRAINS AND SIMILAR MATERIALS."
