RESOLUTION NO. 56

A RESOLUTION ENDORSING AND APPROVING HOUSE BILL NO. 591,
INTRODUCED BY HONORABLE CARMELO J. LOCSIN, CONGRESSMAN,
4TH DISTRICT OF LEYTE, ENTITLED "AN ACT CONVERTING THE
ORMOC CITY HIGH SCHOOL INTO A SCHOOL OF ARTS AND TRADES TO
BE KNOWN AS THE ORMOC CITY SCHOOL OF ARTS AND TRADE AND
APPROPRIATING FUNDS THEREFOR", PROVIDED, HOWEVER, THAT THE
TEXT OF THE SAID BILL SHALL BE AS CONTAINED IN THE AMENDED
VERSION, COPY OF WHICH IS HERETO ATTACHED.

WHEREAS, the Honorable Congressman Carmelo J. Locsin, 4th District-
Leyte, through a letter dated 25 January 1994 addressed the Honorable
Mayor Eufrocino M. Codilla, Sr., this city, has informed the latter of
the amended version of House Bill No. 591 as introduced by the Honorable
Congressman in Congress, entitled "An Act converting the Ormoc City High
School into a school of arts and trades to be known as the Ormoc City
School of Arts and Trade and appropriating funds therefor", and with a
copy of said amended house bill thereto attached;

WHEREAS, the Office of the City Mayor has endorsed the aforecited
letter with a copy of the amended version of House Bill 591 to this
sanggunian for legislative action;

WHEREAS, the Honorable MEMBERS of the SANGGUNIANG PANLUNGSOD ng
ORMOC, in SESSION, mindful to valid personal views of some school
officials in the locality on not favorably endorsing the conversion of
the Ormoc City High School to a vocational or trade school,
NEVERTHELESS, find out more meritorious points in said amended house
bill now with the insertions or incorporation thereto, as parts and
parcels thereof, of the following provisions as contained in said
amended bill, as follow:

- a) Provided, however, that the General Secondary Curriculum of Ormoc City High School shall be maintained. (Last sentence in Section 2 of House Bill 591, as amended);
- b) Provided, however, that the personnel therein employed under existing laws prior to absorption by the Ormoc City School of Arts and Trade are not impaired. (Second sentence of Section 3 of HB 591, as amended); and
- c) Provided, further, that the incumbents of the positions shall remain in the same status until otherwise provided for by the Department of Education, Culture and Sports. (Third sentence under Section 3 of said House Bill, as amended).

NOW, THEREFORE, on motion of Kagawad Benjamin B. Lladoc, Chairman, Committee on Education and Cultural Development, severally seconded by mga Kagawad Jose C. Alfaro, Jr., Claudio P. Larrazabal and Sixto T. Pongos; be it

RESOLVED, AS IT IS HEREBY RESOLVED, to endorse and approve House Bill No. 591, introduced by Honorable Carmelo J. Locsin, Congressman, 4th District- Leyte, entitled "An Act converting the Ormoc City High School into a school of arts and trades to be known as the Ormoc City School of Arts and Trade and appropriating funds therefor"; provided, however, that the text of the said bill shall be as contained in the amended version, copy of which is hereto attached- marked Exhibit A;

ENACTED, March 17, 1994.

RESOLVED, FURTHER, to furnish copies of this resolution, one each, to Honorable Carmelo J. Locsin, Congressman, 4th District- Leyte, with Special Copies to Honorable Senate President Edgardo Angara and the Honorable House Speaker Jose de Venecia, both in Congress of the Philippines, Manila; Honorable Eufrocino M. Codilla, Sr., City Mayor, Ormoc City; the Assistant Division Superintendent, OIC- DECS Ormoc City Division, Ormoc City; and the Principal, Ormoc City High School, Ormoc City;
