A RESOLUTION AUTHORIZING THE HONORABLE CITY MAYOR, EUFROCING M. CVDILLA. SR., TO SIBM FOR AND IN BEHALF OF THE CITY GOVERNMENT OF ORMOC, AS VENDEE, A DEED OF ABSOLUTE SALE WITH BENITO DIEZ, AS VENDOR, INVOLVING LOT NO. 3480-D-2 WITH AN AREA OF 26 SQUARE METERS LOCATED AT BARANGAY DANNIG, ORMOG CITY, FOR ROAD-RIGHT-OF-WAY PURPOSES.

WHEREAS, this august Body is in receipt of an indorsement from the Honorable City Mayor dated 14 February 1994, addressed to the Honorable Vice-Mayor and Presiding Officer of the request of Benito Diez regarding his read-right-of-way claim involving Lot No. 3480-D-2 with an area of 26 sq. m. situated at Brgy. Danhug, this city;

WHEREAS, per Resolution No. 01-94 of the Appraisal Committee dated 18 November 1993, said Lot No. 3480-D-2 was duly appraised at #70.00 per square meter;

WHEREAS, the City Assessor through a certification dated 18 January 1994 has certified that Lot No. 3480-D-2 with an area of 26 sq. m. located at Barangay Danhug, Ormoc City is used by the City Government of Ormoc as road-right-of-way;
