RESOLUTION NO. 61

A RESOLUTION CONFIRMING THE MEMBERSHIP OF HON. ALFREDO F. CAPAHI IN THE COMMITTEE ON AWARDS.

435 of Rule XXXV of the Rules and Regulations WHEREAS, Art. Implementing the Local Sovernment Code of 1991 provides that:

There shall be in every province, city or municipality a dommittee on awards which shall exercise exclusive jurisdiction in deciding the winning bids and questions of swards on procurement and disposal of supplies or property except in cases of procurement through emergency purchase, or when the authorization is specifically vested by law in another body.

The committee on awards shall be composed of the local chief executive as chairman; the local treasurer, the local accountant, the local budget officer, the provincial general services officer, the city general services officer, and the head of office or department for whose use the supplies are being procured, as members. In case a head of office or department would sit in a dual capacity, a member of the sanggunian elected from among its members shall sit as a member":
