RESOLUTION NO. 70

A RESOLUTION REQUESTING THE CHAIRMAN AND THE MEMBERS OF THE APPRAISAL COMMITTEE, THIS CITY, TO ENLIGHTEN THE MEMBERS OF THE SIXTH SANGGUNIANG PANLUNGSOD OF ORMOC REGARDING THEIR CRITERIA AND GUIDELINES AS REGARDS APPRAISAL OF PROPERTIES WITHIN THIS CITY.

WHEREAS, the City Government of Ormoc is faced with several requests for Road-Right-Of-Way claims which are to be paid out of the funds from the city treasury;

WHEREAS, these Road-Right-Of-Way claims which constitute another burden on the part of the city are dependent solely on the appraisal made by the appraisal committee of this city thereby necessitating for a thorough study before recommendations for payment are to be made;

WHEREAS, this Sixth Sangguniang Panlungsod ng Ormoc believes that before payment could be made for these Road-Right-Of-Way claims, this body must first be enlightened as to the criteria and guidelines of the appraisal committee in aid of legislation;



CARRIED UNANIMOUSLY.


