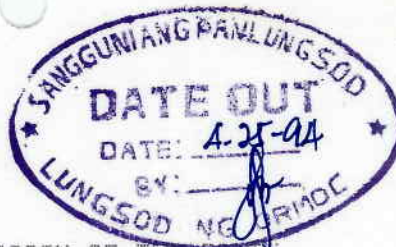

CARRIED UNANIMOUSLY.


