RESOLUTION NO. 72

A RESOLUTION INFORMING THE HONORABLE CITY MAYOR EUFROCINO M. CODILLA, SR. THAT THE SANGGUNIANG PANLUNGSOD NG ORMOC CANNOT GRANT THE AUTHORITY TO SIGN THE DEED OF EXCHANGE BETWEEN THE CITY GOVERNMENT OF ORMOC AND THE INAKI A. LARRAZABAL ENTERPRISES, INC. SINCE THE OLD CADASTRAL ROAD IS A NATIONAL ROAD OWNED BY THE NATIONAL GOVERNMENT.

WHEREAS, the President & General Manager of the Inaki A. Larrazabal Enterprises, Inc. has offered to barter their lot no. 2919-B part, with an area of 4,713 square meter (now used as a road) which is a portion of the land described in, and covered by TCT No. 19560 of the Registry of Deeds for the City of Ormoc, situated at Brgy. Donghol, Ormoc City, with a portion of the Ormoc-Donghol barrio road (old cadastral road) with an area of 2,826 square meters, situated at Brgy. Donghol, Ormoc City, per his letter dated February 10, 1994 addressed to the Honorable City Mayor Eufrocino M. Codilla, Sr.;

WHEREAS, the Honorable City Mayor Eufrocino M. Codilla, Sr., acting on the aforementioned letter of the President & General Manager of the Inaki A. Larrazabal Enterprises, Inc. caused the preparation of a Deed of Exchange by the City Legal Officer, and thereafter, requested the Sangguniang Panlungsod ng Ormoc through its Presiding Officer, to pass a resolution authorizing him to sign the Deed of Exchange;

WHEREAS, the Sangguniang Panlungsod ng Ormoc requested City Engineer Ruben Penserga to verify the ownership of the old cadastral road subject to the deed of exchange;

WHEREAS, City Engineer Ruben Penserga informed the Sangguniang Panlungsod ng Ormoc that the old cadastral road is a National Road owned by the National Government;

RESOLVED, AS IT IS HEREBY RESOLVED, to pass a resolution informing the Honorable City Mayor Eufrocino M. Codilla, Sr. that the Sangguniang Panungsod ng Ormoc cannot grant the authority to sign the deed of exchange between the City Government of Ormoc and the Itaki A. Larrazabal Enterprises, Inc. since the old cadastral road is a National Road owned by the National Government;
