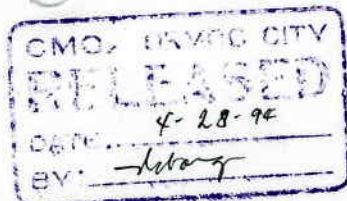
A RESOLUTION AUTHORIZING THE HONORABLE CITY MAYOR EUFROCINO M. CODILLA, SR., TO SIGN FOR AND IN BEHALF OF THE CITY GOVERNMENT OF ORMOC AS VENDEE, A DEED OF ABSOLUTE SALE WITH LOURDES T. JUANILLO AND ERLINDA T. JUANILLO, REPRESENTED IN THIS INSTANCE BY HER ATTY.-IN-FACT, LOURDES T. JUANILLO, AS VENDORS, INVOLVING LOTS NOS. 4-A AND 4-B WITH AN AREA OF 89 SQ. METERS AND 228 SQ. METERS RESPECTIVELY COVERED BY TCT NO. 16128 AND 16129 FOR ROAD-RIGHT-OF-WAY PURPOSES.

WHEREAS, the august Body is in receipt of a letter from the Honorable City Mayor dated 2 February 1994 addressed the Honorable Members of the Sixth Sangguniang Panlungsod, thru the Honorable Vice-Mayor and Presiding Officer, requesting this august Body for the passage of a resolution authorizing the City Mayor to sign the Deed of Absolute Sale with Lourdes T. Juanillo and Erlinda T. Juanillo as vendors involving Lots Nos. 4-A and 4-B with an area of 89 sq. meters and 228 sq. meters respectively covered by TCT Nos. 16128 and 16129, for road-right-of-way purposes;

WHEREAS, per Resolution No. 4-92 dated 8 June 1992 of the Appraisal Committee, said lots were appraised at P250.00 per sq. meters;

WHEREAS, the City Budget Officer through Sixth Indorsement dated 14, September 1993 recommended that said claim be charged against current appropriation -road-right-of-way (Land & Land Improvement Outlay) under the Office of the City Engineer;

WHEREAS, the Office of the Tax Mapping Division, this city has certified that Lots Nos. 4-A and 4-B situated at Ruvi Village, Brgy. Alegria are already used and occupied by the City Government of Ormoc;



WHEREAS, official documents evidencing absolute transfer of ownership of said property is indispensable for records file in government office/s concerned;

NOW, THEREFORE, on motion of Kagawad Alfredo F. Capahi, Chairman, Committee on Finance, duly seconded by Kagawad Benjamin B. Lladoc; be it

RESOLVED, AS IT IS HEREBY RESOLVED, to pass a resolution authorizing the Honorable City Mayor Eufrocino M. Codilla, Sr., to sign for and in behalf of the City Government of Ormoc as vendee, a Deed of Absolute Sale with Lourdes T. Juanillo and Erlinda T. Juanillo, represented in this instance by her Atty.-in-fact, Lourdes T. Juanillo as vendors, involving lots nos. 4-A and 4-B with an area of 139 sq. meters and 228 sq. meters respectively covered by TCT Nos. 16128 and 16129 for road-right-of-way purposes;

RESOLVED, FURTHER, to furnish copies of this resolution each to His Honor, the City Mayor, the City Administrator, the City Legal Officer, the City Treasurer, the City Budget Officer, the Registrar - Register of Deeds and Lot owners Lourdes T. Juanillo and Erlinda T. Juanillo of Brgy. Punta, -all of Ormoc City;
