RESOLUTION NO. 75

A RESOLUTION AUTHORIZING THE HONORABLE CITY MAYOR EUFROCINO M. CODILLA, SR., TO SIGN, FOR AND IN BEHALF OF THE CITY GOVERNMENT OF ORMOC A COMPREHENSIVE HEALTH CARE AGREEMENT BETWEEN THE CITY GOVERNMENT OF ORMOC REFERRED TO AS "ORMOC CITY" AND THE DEPARTMENT OF HEALTH REFERRED TO AS "DOH" WITH JUAN M. FLAVIER, M.D. M.P.H. AS SECRETARY OF HEALTH AND REPRESENTED BY DR. ALFREDO Y. PEREZ, JR., AS REGIONAL DIRECTOR OF DOH REGIONAL FIELD OFFICE NO. 8.

WHEREAS, with the implementation of the Local Government Code of 1991, the functions of the Department of Health (DOH) not only in personal services but also the responsibility of delivering health services to our constituents are entirely transferred, devolved to the Local Government Units (LGU's);

WHEREAS, under the structure of devolution, the City Government of Ormoc becomes cognizant of its new role and responsibilities by recognizing the importance of Local Health Plans which are supportive of the National Health Plan;

WHEREAS, in order to establish a stronger working relationship after devolution of health program to Ormoc City, the DOH and the City Government agree to work together to help ensure the success of Local and National Health Program through a Comprehensive Health Care Agreement;

NOW, THEREFORE, on motion of Kagawad Celso P. Adolfo, Chairman, Committee on Health, Public and Social Welfare, Women and Family, jointly seconded by mga Kagawad Sotero M. Pepito and Benjamin B. Liadoc; be it




