RESOLVITION NO. 76

A RESOLUTION RESPECTFULLY REQUESTING THE HONORABLE SUPREME COURT THROUGH THE HONORABLE CHIEF JUSTICE ANDRES NARVASA TO LAUSE THE IMPLEMENTATION OF ITS EN BANC RESOLUTION VATED RETOVER 12, 1975 TO TRANSFER BRANCH 35, REGIONAL TRIAL COUNT, TACLOBAN CITY TO ORMOC CITY, THEREBY ONGANIZING AND ACTIVATING THE SAME IN ORMOC CITY.

WHEREAS, this august Body, on May 20, 1993 passed Resolution No. 90 parnestly and respectfully requesting Honorable Chief Justice Andres Narvasa, Supreme Court of the Philippines, to create and establish an additional Regional Trial Court in Ormoc City;

MHEREAS, on August 3, 1993, this sanggunian passed Resolution 139 requesting the Honorable Supreme Court to transfer one of the three (3) new Regional Trial Courts in Tacloban City (Branches 34, 35 and 36) to Ormoc City, in order to give real meaning and substance to the constitutional mandate of speedy justice;

WHEREAS, the Honorable Supreme Court in an en banc resolution dated October 12, 1993, resolved to TRANSFER Branch 35, Regional Trial Court, Tacloban City to Ormoc City;

WHEREAS, to date, Branch 35, Regional Trial Court, Tacloban City has not been transferred to Ormoc City, notwithstanding the aforementioned en banc resolution of the Honorable Supreme Court;

WHEREFORE, foregoing premises considered, on motion of Kagawad Mariano Y. Corro, Chairman, Committee on Laws and Ordinances, Jointly seconded by mga Kagawad Westor C. Penserga and Benjamin B. Lladoc; be it

RESOLVED, AS IT IS HEREBY RESOLVED, to pass a resolution respectfully requesting the Honorable Supreme Court through the Honorable Chief Justice Andres Narvasa to cause the implementation of its en banc resolution dated October 12, 1993 to TRANSFER Branch 35, Regional Trial Court, Tacloban City to Ormoc City, soonest, thereby organizing and activating the same in Ormoc City;

RESOLVED, FURTHER, to respectfully request the Honorable Executive Judge Francisco H. Escaño, Jr., Regional Trial Court, Ormoc City, to favorably endorse this Resolution to the Honorable Supreme Court for the early realization of the transfer of Branch 35, Regional Trial Court, Tacloban City to Ormoc City;

RESOLVED, FINALLY, to furnish copies of this resolution, one each, to Honorable Andres Narvasa, Chief Justice of the Supreme Court, Madre Faura, Metro Manila; Honorable Ernani Cruz Paño, Court Administrator, Supreme Court; the Honorable Executive Judge, Regional Trial Court, Tacloban City; the Honorable Executive Judge, Francisco M. Escaño, Jr., Regional Trial Court, Ormoc City; the Honorable City Mayor Exfrocino M. Codilla, Sr., Ormoc City, and all others concerned;
