RESOLUTION NO. 78

A RESOLUTION REQUESTING THE HONORABLE CONGRESSMAN OF THE FOURTH DISTRICT OF LEYTE, HONORABLE CARMELG J. LOCSIN, TO INTRODUCE A BILL IN CONGRESS DECLARING OCTOBER 20 OF EVERY YEAR RS "ADLAW SA ORMOC" (ORMOC CITY CHARTER DAY), A SPECIAL NOW-NORKING HOLIDAY IN THE CITY OF ORMOC.

NHERENS, by virtue of Republic Act No. 179, the then Municipality of Ormoc became a CHARTERED CITY;

WHEREAS, the late President Manuel A. Roxas on September 4, 1947 issued Presidential Proclamation No. 42, fixing October 20, 1947 as the date for the inauguration of Ormoc City;

WHEREAS, it is proper that the people of the City of Ormoc should be given the full opportunity to celebrate the foundation anniversary of Ormoc City with fitting ceremonies;

WHEREAS, there is a need to focus public attention on the accomplishment and progress of the City so as to stimulate the interest, cooperation and participation of the residents therein;

WHEREAS, the foundation anniversary of other Local Government Units has been declared by an Act of Congress a special non-working holiday, notably: Republic Act 7550, "Declaring February 16 of every year as Caloocan City Day, a special non-working holiday in Caloocan City", Republic Act 7551, "Declaring March 16 of every year as Araw ng Davao, a special non-working public holiday in Davao City", Republic Act No. 7552, "Declaring May Seven of every year as a special non-working holiday in the Province of Pampanga", and Republic Act 7553, "Declaring June Nineteen of every year as a special non-working holiday in the Province of Surigao del Norte";

WHEREAS, it is the feeling and desire of the members of this august Body that the foundation anniversary of the City of Grmoc be likewise declared by an Act of Congress as a special non-working holiday in the City of Grmoc;
