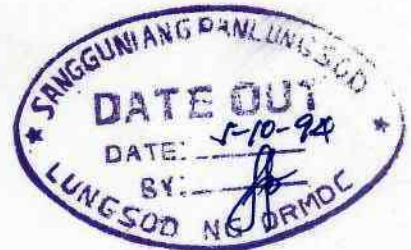

THE ORMOC PORT;

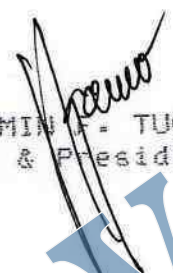

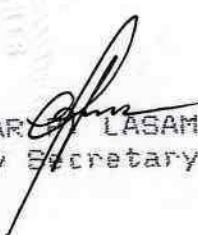

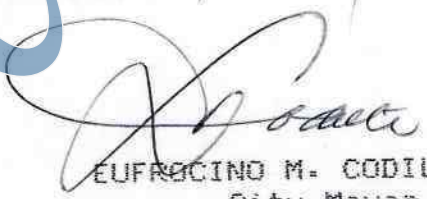
