A RESOLUTION AUTHORIZING THE HONORABLE CITY MAYOR EUFROCINO M. CODILLA, SR., TO SIGN, FOR AND IN BEHALF OF THE CITY GOVERNMENT OF ORMOC A MEMORANDUM OF AGREEMENT WITH THE PHILIPPINE TOURISM AUTHORITY REPRESENTED BY ITS GENERAL MANAGER EDUARDO T. JOAQUIN ON THE ORMOC CITY STREETLIGHTING.

WHEREAS, this august Body is in receipt of an indorsement dated 11 May 1994 from the Honorable City Mayor, addressed the Honorable Vice-Mayor and Presiding Officer, of the letter of VIRGILIO S. BENEDICTO, Deputy General Manager for Tourism Estate & Infrastructure Sector, Philippine Tourism Authority together with the enclosed Memorandum of Agreement on the Ormoc City Streetlighting, requesting for a passage of a resolution confirming/ratifying the aforecited contract per COA Memorandum dated August 16, 1991.


