A RESOLUTION APPROVING RESOLUTION NO. 6 S. 1994 OF THE CITY  
DEVELOPMENT COUNCIL (CDC) ENTITLED, "A RESOLUTION  
APPROVING THE REALIGNMENT OF THE CONSTRUCTION OF MULTI-  
PURPOSE PAVEMENT AT BRGY. COGON-BILIBOY IN THE AMOUNT OF  
TWO HUNDRED TWENTY THOUSAND PESOS (P220,000.00) TO THE  
CONSTRUCTION OF MULTI-PURPOSE PAVEMENT AT BRGY. COGON  
(CALAMANSANOY ST.) OF THE SAME AMOUNT AND REQUESTING THE  
HONORABLE SANGGUNIANG PANLUNGSOD NG ORMOC FOR APPROVAL OF  
THE SAME".

WHEREAS, this august Body is in receipt of Resolution No. 6 s.  
1994 of the City Development Council (CDC) entitled, "A Resolution  
Approving the Realignment of the Construction of Multi-Purpose Pavement  
at Brgy. Cogon-Biliboy in the amount of Two Hundred Twenty Thousand  
Pesos (P220,000.00) to the Construction of Multi-Purpose Pavement at  
Brgy. Cogon (Calamansanoy St.) of the same amount and requesting the  
Honorable Sangguniang Panlungsod ng Ormoc for approval of the same";
