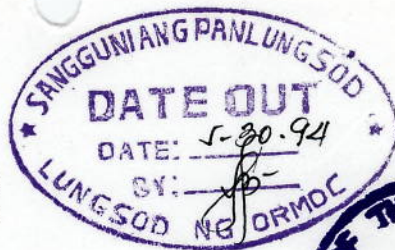

RESOLUTION NO. 93

A RESOLUTION AUTHORIZING THE HONORABLE CITY MAYOR EUFROCINO M. CODILLA, SR. TO ENTER INTO A NEGOTIATED CONTRACT WITH THE JOINT VENTURE CONTRACTOR FOR THE CONSTRUCTION OF PHASE II PROJECT OF THE ORMOC SHOPPING MALL.

WHEREAS, PBAC Unnumbered Resolution dated 20 April 1994 Re: Negotiated Contract with the Joint Venture be undertaken in the Construction of Phase II Project- Ormoc Shopping Mall, has cited the following contentions:

- a) That the contractor- Joint Venture, on the ongoing Phase I construction of Shopping Mall, "has no negative slippage and has demonstrated a satisfactory performance";
- b) That Phase II construction of Shopping Mall, which is a contiguous work immediately after Phase I, could be economically prosecuted by the Joint Venture, for there is less mobilization cost considering that the heavy equipments of said contractor are already available at the site.

WHEREAS, acting on the favorable recommendation of said PBAC Resolution, the Honorable City Mayor has requested in writing the Honorable Sangguniang Panlungsod for authority to enter into a negotiated contract with the Joint Venture for the construction of Phase II project- Shopping Mall;

WHEREAS, this august Body, through the representation of the Honorable Chairman, Committee on Infrastructures, has considered the request of the City Mayor reasonable, hence, must be accorded with due course of action;


