RESOLUTION NO. 96

A RESOLUTION AUTHORIZING THE CITY TREASURER FOR THE ADVANCE
PAYMENT OF ONE-HALF OF THE CHRISTMAS BONUS AND ADDITIONAL
CASH GIFT UNDER THE 1994 ANNUAL BUDGET TO LOCAL
GOVERNMENT OFFICIALS AND EMPLOYEES.

WHEREAS, this sanggunian is in receipt of a letter dated 30 May 1994 from the Honorable City Mayor, said letter having requested for passage of a resolution authorizing the City Treasurer for advance payment to government officials and employees of the local government of one-half (1/2) of the Christmas Bonus and Additional Cash Gift under the 1994 Annual Budget;

WHEREAS, the said letter has further contended that advance payment of one-half of the Christmas Bonus and Cash Gift is in order "to stimulate economic activities in the first semester of 1994 and help defray the expenses of government officials and employees associated with the opening of the school year", and still further cited that this "resolution shall contain the following provisions: a) entitled to such benefits are regular officials and employees who have rendered at least four (4) months of service from 1 January to 15 May 1994 and who are employed in the government service as of 15 May 1994, and b) an employee who resigns before 31 October 1994 shall be required to refund the amount received";

WHEREAS, this august Body, through the representation of the Honorable Chairman, Committee on Finance, has considered the request of the City Mayor reasonable, hence, must be accorded with due course of action;

NOW, THEREFORE, on motion of Kagawad Alfredo F. Capahi, Chairman, Committee on Finance, duly seconded by Kagawad Claudio P. Larrazabal; be it
