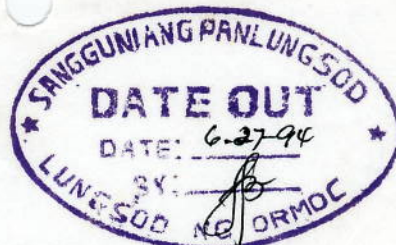

it


RESOLVED, AS IT IS HEREBY RESOLVED, to approve Supplemental Budget


RESOLVED, FURTHER, to furnish copies of this resolution each to


