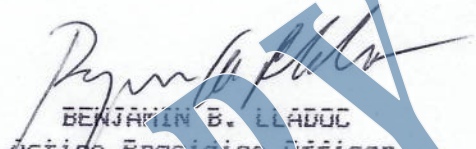
RESOLVED, AS IT IS HEREBY RESOLVED, to support and endorse

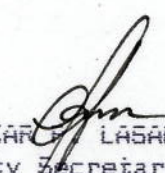
