A RESOLUTION TO RETURN TO THE BARANGAY COUNCIL OF CABINGTAN, ORMOC CITY THEIR ORDINANCE NO. 4 S. 1994 ENTITLED "AN ORDINANCE IMPOSING A CURFEW WITHIN THE JURIDICAL METES AND BOUNDS OF BARANGAY CABINGTAN" WITH THE REQUEST THAT THE SAME BE AMENDED, ADJUSTED OR MODIFIED ACCORDINGLY CONSIDERING THE OBSERVATION OF THE CITY LEGAL OFFICER IN HIS 3RD INDORSEMENT DATED 27 JUNE 1994 COPY OF WHICH IS HERETO ATTACHED AND TO RECONCILE WITH RESOLUTION NO. 2 S. 1994 OF THE SAME BARANGAY.

WHEREAS, this august Body is in receipt of Resolution No. 4 s. 1994 embodying Ordinance No. 4 of the Barangay Council of Cabingtán, this city, entitled, "AN ORDINANCE IMPOSING A CURFEW WITHIN THE JURIDICAL METES AND BOUNDS OF BARANGAY CABINGTAN, ORMOC CITY";




