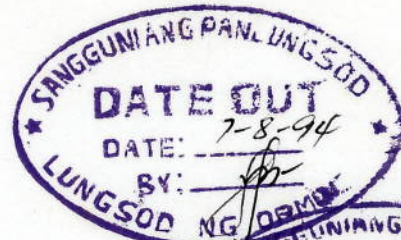

requirements and other budgetary issuances;

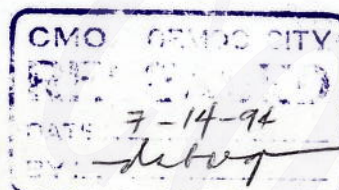
WHEREAS, this august Body has conformed to the findings of the
