RESOLUTION NO. 116

A RESOLUTION REQUESTING/RECOMMENDING TO GENERAL RICARDO GARMIENTO III, CHIEF PNP, CAMP CRAME, QUEZON CITY AND BRIG. GEN. ROGELIO PUREZA, REGIONAL DIRECTOR, REGION VIII, CAMP R. KANGLEON, TACLOBAN CITY THE RETENTION AND APPOINTMENT OF COL. JOEL S. MANALILI AS CITY POLICE DIRECTOR AND MAJ. ARNULFO T. CRUZ AS PRECINCT POLICE COMMANDER OF ORMOC CITY.

WHEREAS, this august Body is in receipt of a letter from the Hon. City Mayor dated 5 July 1994 requesting for a passage of a resolution retaining the services of Col. Joel S. Manalili as City Police Director and Maj. Arnulfo T. Cruz as Precinct Police Commander in Ormoc in relation to NAPOLCOM Resolution No. 92-36 concerning the revised reorganization of the Philippine National Police effective July 1, 1994;

WHEREAS, under said NAPOLCOM issuances, the Ormoc Metropolitan District Command is one of those deactivated and shall be transferred to the concerned Highly Urbanized City Police Station which shall henceforth be called "City Police Command" and placed under the direct command and control of the Regional Director;

WHEREAS, Col. Joel S. Manalili has been with the Ormoc PNP for quite a time and has demonstrated exemplary and meritorious services as Metrodiscom Commander and for whose invaluable services the City of Ormoc has attained exemplary peace and order situation. Likewise, Maj. Arnulfo T. Cruz has also rendered meritorious and exemplary services to Ormoc, in fact the Ormoc Police Station was adjudged the best or Number 1 Police Station in Region 8 and Number 2 in National level under his command;

WHEREAS, the Sixth Sangguniang Panlungsod ng Ormoc, through the representation of the Honorable Chairman, Committee on Police, Fire and Public Safety, has considered said request as valid and reasonable, hence, must be accorded with the necessary course of action;

NOW, THEREFORE, on motion of Kagawad Jose C. Alfaro, Jr., Chairman, Committee on Police, Fire and Public Safety jointly seconded by Kagawad Alfredo F. Capahi and Benjamin B. Liadoc, be it;

RESOLVED, AS IT IS HEREBY RESOLVED, to pass a resolution requesting/recommending to Gen. Ricarido Sarmiento III, Chief PNP, Camp Crame, Quezon City, and Brig. Gen. Rogelio Pureza, Regional Director VIII, Camp R. Kangleon, Tacloban City the retention and appointment of Col. Joel S. Manalili as City Police Director and Maj. Arnulfo T. Cruz as Precinct Police Commander of Ormoc City;
