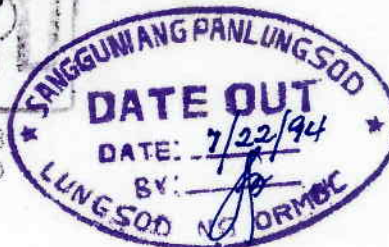

RESOLUTION NO. 123

A RESOLUTION APPROVING ORDINANCE NO. 1 S. 1994 OF THE
SANGGUNIANG BARANGAY OF BRGY. CAN-ADIENG, ORMOC CITY,
ENTITLED, "PROHIBITING THE USE OF BARANGAY ROADS, PARKS
AND SQUARES FOR BASKETBALL COURT AND OTHER SIMILAR
MATERIALS".

WHEREAS, this august Body is in receipt of Ordinance No. 01 s. 1994
of the Barangay Council of Brgy. Can-adieng, this city, entitled
"PROHIBITING THE USE OF BARANGAY ROADS, PARKS AND SQUARES FOR BASKETBALL
COURT AND OTHER SIMILAR MATERIALS";

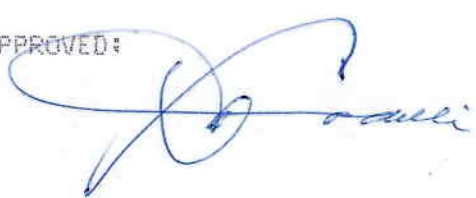
