RESOLUTION NO. 128

A RESOLUTION APPROVING CDC EXECUTIVE COMMITTEE'S RESOLUTION NO. 6 S. 1994 ENTITLED "A RESOLUTION APPROVING THE REALIGNMENT OF THE CONSTRUCTION OF MULTI-PURPOSE PAVEMENT AT BRGY. PATAG IN THE AMOUNT OF TWO HUNDRED FIFTEEN THOUSAND TWO HUNDRED FIFTY PESOS & 00/100, (P215,250.00), TO THE CONSTRUCTION OF MULTI-PURPOSE PAVEMENT AT BRGY. ALTA VISTA OF THE SAME AMOUNT AND REQUESTING THE HONORABLE SANGGUNIANG PANLUNGSOD NG ORMOC FOR APPROVAL OF THE SAME."

WHEREAS, this august Body is in receipt of CDC Executive Committee's Resolution No. 6 s. 1994 entitled "A Resolution approving the realignment of the construction of Multi-Purpose Pavement at Brgy. Patag in the amount of Two Hundred Fifteen Thousand Two Hundred Fifty Pesos & 00/100, (P215,250.00), to the construction of Multi-Purpose Pavement at Brgy. Alta Vista of the same amount and requesting the Honorable Sangguniang Panlungsod ng Ormoc for approval of the same";

WHEREAS, a separate attachment in said CDC Resolution No. 6 is Resolution No. 05 s. 1994 of the Barangay Council of Brgy. Patag, this city, to the effect granting or manifesting consent to the said realignment for "it has been observed that the present barangay road of Barangay Patag wherein the proposed Multi-Purpose Pavement is to be constructed is now a very deep canal, so that implementation of the said project becomes impractical", and that "Brgy. Alta Vista is adjacent to Brgy. Patag and the residents of the latter are even using the road of the former";

WHEREAS, the Sixth Sangguniang Panlungsod ng Ormoc, through the representation of the Honorable Chairman, Committee on Infrastructures, has considered the said realignment as valid and reasonable considering that it is included in this year 1994 list of priorities, hence, needs immediate implementation;

PATAG IN THE AMOUNT OF TWO HUNDRED FIFTEEN THOUSAND TWO HUNDRED FIFTY PESOS, (P215,250.00), TO THE CONSTRUCTION OF MULTI-PURPOSE PAVEMENT AT BRGY. ALTA VISTA OF THE SAME AMOUNT AND REQUESTING THE HONORABLE SANGGUNIANG PANLUNGSOD NG ORMOC FOR APPROVAL OF THE SAME;
