RESOLUTION NO. 133

A RESOLUTION APPROVING ORDINANCE NO. 94-002 OF THE BARANGAY COUNCIL OF LAO, ORMOG CITY, ENTITLED "AN ORDINANCE PROHIBITING ASTRAY ANIMALS SUCH AS PIGS, GOATS, CARABAOS, COWS, HORSES, ETC., FROM ROAMING AROUND THE BARANGAY PLAZA, SCHOOL PREMISES, AND OTHER PUBLIC AND PRIVATE PLACES, PROVIDING PENALTIES IN VIOLATION THEREOF".

WHEREAS, this august Body is in receipt of Ordinance No. 94-002 of the Barangay Council of Lao, this city, entitled "An Ordinance prohibiting astray animals such as pigs, goats, carabaos, cows, horses, etc., from roaming around the barangay plaza, school premises, and other public and private places, providing penalties in violation thereof";
