SANGGUNIANG PANLALAWIGAN OF KALINGA-APAYAO RE ENDORSING
AND STRONGLY SUPPORTING RESOLUTION NO. 60 S. 1994 OF THE
SANGGUNIANG PANLALAWIGAN OF CAMIGUIN, SUPPORTING THE
CONDUCT OF MID-DECADE CENSUS OF POPULATION NATIONWIDE BY
THE NATIONAL STATISTICS OFFICE, AND ASKING CONGRESS TO
ALLOCATE FUNDS FOR THIS ACTIVITY.

WHEREAS, the Sangguniang Panlungsod ng Ormoc is in receipt of
Resolution No. 94-179 from the Sangguniang Panlalawigan of Kalinga-
Apayao, Tabuk, endorsing and strongly supporting Resolution No. 60 S.
