increase in all forms of illegal fishing activities caused, among others, by the lack of coordinated efforts among concerned agencies in the implementation of fishery laws and measures has been observed by duly constituted authorities resulting to the alarming degradation of the marine environment and eroding the very source of marine life which many Filipinos rely on for sustenance;

WHEREAS, the exploitation of the Ormoc Bay should be checked through an integrated effort such as the Bay Management Council covering the three (3) Municipalities along the Ormoc Bay to protect the marine environment and in respond to the clamor of the small marginalized fishermen, for immediate government attention and concern regarding their plight;

NOW, THEREFORE, on motion of Kagawad Jose C. Alfaro, Jr., Chairman, Committee on Natural Resources and Environmental Control duly seconded by Kagawad Benjamin B. Liadoc; be it
