RESOLUTION NO. 144

A RESOLUTION AUTHORIZING THE HONORABLE CITY MAYOR OF ORMOC
TO REPRESENT THE CITY AND ENTER INTO AN AGREEMENT WITH THE
OTHER MUNICIPAL MAYORS OF THE MUNICIPALITIES ALONG ORMOC
BAY TO SUPPORT THE BAY MANAGEMENT COUNCIL IN THE
MANAGEMENT OF THE ORMOC BAY.

WHEREAS, an increase in all forms of illegal fishing activities
caused, among others, by the lack of coordinated efforts among concerned
agencies in the implementation of fishery laws and measures has been
observed by duly constituted authorities resulting to the alarming
degradation of the marine environment and eroding the very source of
marine life which many Filipinos rely on for sustenance;

WHEREAS, the exploitation of the Ormoc Bay should be checked
through an integrated effort such as the Bay Management Council covering
the three (3) Municipalities along the Ormoc Bay to protect the marine
environment and in respond to the clamor of the small marginalized
fishermen, for immediate government attention and concern regarding
their plight;

NOW, THEREFORE, on motion of Kagawad Jose C. Alfaro, Jr., Chairman,
Committee on Natural Resources and Environmental Control duly seconded
by Kagawad Benjamin B. Lladoc; be it

RESOLVED, AS IT IS HEREBY RESOLVED, to pass a resolution
Authorizing the Honorable City Mayor of Ormoc to represent the City and
