RESOLUTION NO. 147

A RESOLUTION INFORMING CENR OFFICER ELMER M. GAPAY OF CENRO
ORMOC CITY, IN CONNECTION WITH THE MISCELLANEOUS LEASE
APPLICATION (ILA NO. 083738-7) OF MRS. GWENDOLYN O.
CIDLILLA, THAT PER RESOLUTION NO. 45 SERIES OF 1967 OF THE
THEN MUNICIPAL BOARD OF ORMOC CITY, PUBLIC LANDS WITHIN
THE TERRITORIAL BOUNDARIES OF ORMOC CITY FOR WHICH THE
CITY GOVERNMENT IS GIVEN THE RESERVATION, IS RESERVED FOR
THE FUTURE USE OF THE CITY GOVERNMENT OF ORMOC.

WHEREAS, this august Body is in receipt of a letter dated August 23, 1994 of CENR Officer Elmer M. Gapay of CENRO, Ormoc City, requesting that he be advised whether the land applied for miscellaneous lease by Mrs. Gwendolyn Codilia is or may be needed by the Government for public improvement;

WHEREAS, per Resolution No. 45, Series of 1967, of the then Municipal Board of Ormoc City, public lands within the territorial boundaries of Ormoc City for which the City Government is given reservation is reserved for the future use of the City Government of Ormoc;

WHEREAS, per opinion of the City Legal Officer Cleto L. Evangelista, Jr., dated August 2, 1993, in part stated:

"Resolution No. 45 reserves for the City of Ormoc the future use of all public lands within the territorial jurisdiction of Ormoc City."

"To this date no Resolution has been passed by the previous legislative councils repealing Resolution No. 45, nor has the present 6th Sangguniang Panlungsod in the

exercise of its aforesited powers revoked the said Resolution No. 45.

"Thus, as it is, Resolution No. 45, remains valid and existing."

WHEREAS, this Legislative body on similar requests for the release of public lands within the territorial boundaries of Ormoc City, subject either of miscellaneous lease or sales applications have DENIED the same relying on for its action aforesited Resolution No. 45;

WHEREFORE, foregoing premises considered, on motion of Kagawad Mariano Y. Corro, Chairman, Committee on Public Properties, and duly seconded by Kagawad Sotero M. Pepito; be it

RESOLVED, AS IT IS HEREBY RESOLVED, to pass a resolution informing CENR Officer Elmer M. Gapay of CENRO - Ormoc City, in connection with the miscellaneous lease application of Mrs. Gwendolyn G. Cadilla, that per Resolution No. 45 Series of 1967 of the then Municipal Board of Ormoc City, Public lands within the territorial boundaries of Ormoc City for which the City Government is given reservation, is reserved for the future use of the City Government of Ormoc;


