CODILLA, SR., CITY MAYOR, ORMOC CITY, FOR THE INSTALLATION OF ELECTRIC POWER LINES TO BARANGAY CABINGTAN, ORMOC CITY".

WHEREAS, this august Body is in receipt of a copy of Resolution No. 14, Series of 1994 of the Sangguniang Barangay of Barangay Cabingtán, entitled: "A RESOLUTION EARNESTLY AND URGENTLY REQUESTING LEYECO V MANAGEMENT THROUGH THE HONORABLE EUFROCINO M.
