REQUESIONS THE OFFICER-IN-CHARGE OF THE CITY A RESOLUTION PLANNING AND DEVELOPMENT OFFICE, ORMOC CITY, TO PREPARE THE OVERALL PHYSICAL AND ARCHITECTURAL PLANS AND MOTIF OF THE GOVERNMENT CENTER WHICH WILL SERVE AS A GUIDE IN THE CONSTRUCTION OF BUILDINGS THEREAT, AND TO SUBMIT THE SAME TO THE SANGGUNIANG PANLUNGSOD FOR APPROVAL AS PROVIDED FOR IN ARTICLE 8, PARAGRAPH (C) OF THE RULES AND REGULATIONS INPLEMENTING THE LOCAL GOVERNMENT CODE OF 1991.

WHEREAS, Article 8 of the Rules and Regulations Implementing the Local Government Code of 1991 encourages LGUs to establish government center where offices, agencies, or branches of the National Government, or Government Owned or Controlled Corporations can be located;

WHEREAS, the City Government of Ormoc has already established its Government Center;

WHEREAS, Article 8, Paragraph (c) of the Rules and Regulations Implementing the Local Government Code of 1991 provides:

"Construction of buildings in the government center shall conform with the overall physical and architectural plans and motif of the government center, as approved by the sanggunian concerned."

WHEREAS, to comply with the aforequoted provisions of the Rules and Regulations Implementing the Local Government Code of 1991, the appropriate office of the City Government of Ormoc to undertake the task is the Office of the City Planning and Development of Ormoc;
