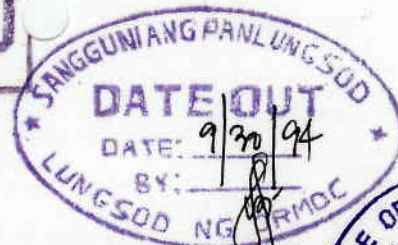

Supplemental Budgets No. 02 for CY 1994 of the following barangays:

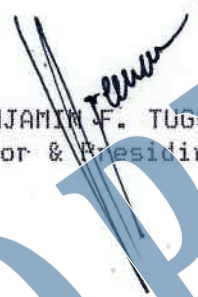
