sibmitted to this Sanggunian for review pursuant to WHEREAS, submitted to this Sanggunian for review pursuant to Section 57 of Republic Act 7160, otherwise known as the Local Government of 1971, is Ordinance No. 94-002 of the Sangguniang Barangay of Green Valley, this city, entitled: "AN ORDINANCE IMPOSING A Rarangay Green Valley, this city, entitled: "AN ORDINANCE IMPOSING A CURPEW, TO ALL PERSONS, WITHIN THE JURISDICTION OF THIS BARANGAY, FROM 10:00 O'CLOCK IN THE EVENING TO 4:00 O'CLOCK IN THE MORNING, PROVIDING PENALTIES AND EXCEPTIONS THEREOF";

WHEREAS, the review made by the Sanggunian of the aforementioned Ordinance disclosed the following defects:

- That Section 5, Paragraph C thereof provides the penalty of "imprisonment of not less than 15 days" which provision is beyond the power of the Sangguniang Barangay to impose, as Section 391, Paragraph A, sub-paragraph 14 of the Local Government Code of 1991 empowers Sangguniang Barangay to "Prescribe fines in the amount not exceeding ₱1,000.00 for violation of Barangay Ordinance";
- The title of Sec. 9 which reads "Separability" should changed to "Repealing Clause";
- That another Section providing for "Separability" may added.

Res. No. 162 NOW, THEREFORE, on motion of Kagawad Mariano Y. Corro, Chairman, Committee on Laws and Ordinances, duly seconded by Kagawad Benjamin B. Lladoc, be it
