## RESOLUTION NO. 174

A RESOLUTION APPROVING ORDINANCE NO. 94-002 S. 1994 OF THE SANGOUNIANS BARANGAY OF MARGEN, ENTITLED "AN ORDINANCE PROPERTY ASTRAY ANIMALS, SUCH AS PIGS, GOATS, CARABADS, COWS, MORSES, ETC., FROM ROAMING AROUND THE BARANGAY PLAZA, SCHOOL PREMISES, AND OTHER PUBLIC AND PRIVATE PLACES, AROVINING PENALTIES IN VIOLATION THEREOF".

WHEREAS, this august Body is in receipt of Ordinance No. 94-002 of the Barangay Council of Margen, this city, entitled "AN ORDINANCE ROHIBITING ASTRAY ANIMALS SUCH AS PIGS, GOATS, CARABAOS, COWS, HORSES, ETC., TROM ROAMING AROUND THE BARANGAY PLAZA, SCHOOL PREMISES, AND OTHER PUBLIC AND PRIVATE PLACES, PROVIDING PENALTIES IN VIOLATION THEREOF";
